Adjourn:

- (a) Permitted Purposes. It is the policy of this State that closed sessions shall be held only when required to permit a public body to act in the public interest as permitted in this section. A public body may hold a closed session and exclude the public only when a closed session is required:
- (1) To prevent the disclosure of information that is privileged or confidential pursuant to the law of this State or of the United States, or not considered a public record within the meaning of Chapter 132 of the General Statutes.
- (2) To prevent the premature disclosure of an honorary degree, scholarship, prize, or similar award.
- (3) To consult with an attorney employed or retained by the public body in order to preserve the attorney-client privilege between the attorney and the public body, which privilege is hereby acknowledged. General policy matters may not be discussed in a closed session and nothing herein shall be construed to permit a public body to close a meeting that otherwise would be open merely because an attorney employed or retained by the public body is a participant. The public body may consider and give instructions to an attorney concerning the handling or settlement of a claim, judicial action, mediation, arbitration, or administrative procedure. If the public body has approved or considered a settlement, other than a malpractice settlement by or on behalf of a hospital, in closed session, the terms of that settlement shall be reported to the public body and entered into its minutes as soon as possible within a reasonable time after the settlement is concluded.
- (4) To discuss matters relating to the location or expansion of industries or other businesses in the area served by the public body, including agreement on a tentative list of economic development incentives that may be offered by the public body in negotiations, or to discuss matters relating to military installation closure or realignment. Any action approving the signing of an economic development contract or commitment, or the action authorizing the payment of economic development expenditures, shall be taken in an open session.
- (5) To establish, or to instruct the public body's staff or negotiating agents concerning the position to be taken by or on behalf of the public body in negotiating (i) the price and other material terms of a contract or proposed contract for the acquisition of real property by purchase, option, exchange, or lease; or (ii) the amount of compensation and other material terms of an employment contract or proposed employment contract.
- (6) To consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee; or to hear or investigate a complaint, charge, or grievance by or against an individual public officer or employee. General personnel policy issues may not be considered in a closed session. A public body may not consider the qualifications, competence, performance, character, fitness, appointment, or removal of a member of the public body or another body and may not consider or fill a vacancy among its own membership except in an open meeting. Final action making an appointment or discharge or removal by a public body having final authority for the appointment or discharge or removal shall be taken in an open meeting.
- (7) To plan, conduct, or hear reports concerning investigations of alleged criminal misconduct.
- (8) To formulate plans by a local board of education relating to emergency response to incidents of school violence or to formulate and adopt the school safety components of school improvement plans by a local board of education or a school improvement team.
- (9) To discuss and take action regarding plans to protect public safety as it relates to existing or potential terrorist activity and to receive briefings by staff members, legal counsel, or law enforcement or emergency service officials concerning actions taken or to be taken to respond to such activity.
- (10) To view a recording released pursuant to G.S. 132-1.4A. (b) Repealed by Session Laws 1991, c. 694, s. 4. (c) Calling a Closed Session. A public body may hold a closed session only upon a motion duly made and adopted at an open meeting. Every motion to close a meeting shall cite one or more of the permissible purposes listed in subsection (a) of this section. A motion based on subdivision (a)(1) of this section shall also state the name or citation of the law that renders the information to be discussed privileged or confidential. A motion based on subdivision (a)(3) of this section shall identify the parties in each existing lawsuit concerning which the public body expects to receive advice during the closed session.

Stoneville Town Council Meeting Minutes November 1, 2022 7:00 PM-Council Chambers

Present: Present were Mayor Kathy Stanley-Galvan, Councilmen Henry Thornton, Chuck Hundley, Jerry Smith, Johnny Farmer and Curtis Bennett. Also present were Interim Town Manager Perry Webster, Finance/HR Officer Samuel Stewart and Town Attorney Eugene Russell.

Closed Session §143-318.11 (4) & (6): Councilman Smith made the motion to enter into closed session. Councilman Bennett seconded. Motion carried.

Motion to come out of closed session made by Councilman Thornton. Councilman Bennett

seconded. Motion carried.

Regular Meeting:

Present were Mayor Kathy Stanley-Galvan, Councilmen Jerry Smith, Henry Thornton, Chuck Hundley, Johnny Farmer and Curtis Bennett. Also present were Interim Town Manager Perry Webster, Town Clerk Sherri Darnell, Finance/HR Officer Samuel Stewart, Fire Chief Joel Freeman and Town Attorney Eugene Russell.

Welcome: Mayor Galvan welcomed the assembly. After the Pledge of Allegiance and Invocation, called the meeting to order.

Mayor Galvan stated that during the closed session a personnel issue and an economic development issue were discussed with no action taken.

Minutes: Mayor Galvan asked for a motion to approve the Minutes from the last meeting. Councilman Farmer made the motion to approve the minutes. Councilman Hundley seconded. Motion carried.

Agenda: Mayor Galvan asked for a motion to approve the Agenda. Councilman Smith made the motion. Councilman Bennett seconded. Motion carried.

New Business:

Proclamation for National Indian Heritage Month: Clerk Darnell read the proclamation into the record. Copy incorporated into the minutes.

Public Hearing Regarding Annexation of 126 Deaton Loop:Councilman Smith made the motion to enter into Public Hearing. Councilman Thornton seconded. Motion carried.

Town Manager Webster stated that interest was shown at the last meeting to annex this property. The property owner is currently on water and will be tapping on to sewer. After some discussion and no public comments, Councilman Thornton made the motion to close the Public Hearing. Councilman Smith seconded. Motion carried.

a. Ordinance O-2022-03 Annexation of 126 Deaton Loop Property: Councilman Farmer made the motion to adopt this ordinance. Councilman Bennett seconded. Motion carried. Copy incorporated into the minutes.

American Response Plan Resolution R-2022-2: Town Manager Webster stated that adoption of this resolution would be required for usage of the pandemic relief funds. Councilman Hundley made the motion to adopt this resolution. Councilman Farmer seconded. Motion carried.

Copy incorporated into the minutes.

Budget Amendments: Finance Officer Stewart presented the Budget Amendments. After some discussion, Councilman Hundley made the motion to approve the amendments. Councilman Thornton seconded. Motion carried. Copies incorporated into the minutes.

Grant Proposal to Hire School Resource Officer: Stephanie Ellis with Rockingham County Schools presented a grant proposal offered through the NC Center for Safe Schools. If awarded, the Town will hire the qualified person and the grant will cover 83% of the salary for two years with the remaining 17% covered by the Town. After some discussion, Councilman Farmer made the motion to accept the proposal from Rockingham County Schools for 2 years. Councilman Bennett seconded. Motion carried. Copy incorporated into the minutes.

Purchase Building through Champion Steel for Public Works:

Town Manager Webster asked if we still wanted to purchase the building from Champion Steel; if so, we need to accept the proposal and send the 15% or \$17,400.00 in order to obtain the drawings. Councilman Farmer made the motion to approve the 15% deposit to get started with Champion. Councilman Thornton seconded. Motion carried. Copy incorporated into the minutes.

Demolish Building at 104 E Main Street (formerly Asignco): Town Manager Webster recommended proceeding with the demolition of the building and using this area along with the vacant lot at 102 E Main Street for much needed parking for the downtown area. Councilman Farmer made the motion to proceed with the demolition of the building. Councilman Thornton seconded. Motion carried.

Public Comments: Sarah Chandler spoke in favor of keeping siren

Fire Department Siren: Town Manager Webster stated that via our Facebook post, popular opinion is to keep the siren. However, Chief Freeman stated that the whole siren will need to be revamped soon because the low band frequency will be leaving. This will require getting quotes and finding the funds to replace it.

Departmental Reports:

Fire: Chief Freeman reports, still trying to find recruits. Equipment has been serviced and we are limited on certified personnel.

Police: Chief Moore reports, thank you for the SRO approval, still trying to fill the 5th full time position and part-time personnel and passed the SBI audit.

Recreation: Director Blackard sent an email reporting registering youth for basketball. 6 men's teams beginning November 10th. Preparing for the Christmas parade. Seniors on the move every Wednesday Vera Holland Center 11am.

Public Works: Director Bowman reports, still working on what you can see and what you can't. Several leaks still to be fixed.

Old Business: None

Town Manager's Update:

Town Manager Webster reported:

- 1. Downtown (Henry and Main St) short of parking especially handicapped spaces. We need to try to find or make additional parking available, especially handicapped areas.
- 2. The Public Works Building (50' X 70') will be ordered on November 2 and await drawings.
- 3. Lemons Street paving is not complete yet, hopefully by the end of the week.
- **4.** Stoneville Memorial Park has cameras installed. Bathroom remodel should begin in a few weeks.
- 5. Christmas Parade is Saturday, December 3 at 1 pm.
- 6. Considering best time to have the Senior Breakfast.
- 7. Parade sponsor CGS Environmental.
