- Water-Sewer bills must be paid by 5:00 p.m. on the 20<sup>th</sup> of every month.
- A 10% late fee will be added if not paid by 5:00 p.m. on the 20<sup>th</sup>.
- When Town Hall is closed on the 20<sup>th</sup>, payments received by 5:00 p.m. on the next business day will be processed with no late fee.
- **A \$50 delinquent fee will be applied to the customer's account if the full balance is not paid by the 27<sup>th</sup> of each month and water service will be cut-off. When Town Hall is closed on the 27<sup>th</sup>, payments received by 5:00 p.m. on the next business day will be processed with no delinquent fee or cut-off.**
- **The full balance due and the delinquent fee must be paid to restore service.**
