Stoneville Town Council Special Meeting Minutes June 27, 2017 6:00 PM

Present:

Present were Mayor Ricky Craddock, Mayor Pro-Tem Chuck Hundley, Councilwoman Lori Armstrong, Councilmen Henry Thornton, Bill Farris and Jerry Smith.

Also, present were Town Manager Ken Gamble, Human Resource/Finance Officer Joanna Dalton, Town Clerk Sherri Darnell, Police Chief Frank Moore, Police Captain Brandon Rivera, Police Officer Lee Edwards, Police Administrative Assistant Perry Webster and Public Works Director Mark Malloy.

Welcome:

Mayor Ricky Craddock welcomed the assembly. After the Pledge of Allegiance and Invocation, Mayor Craddock called the meeting to order.

Minutes:

Mayor Ricky Craddock asked if there were any corrections to the minutes from the last meeting. With no corrections, Mayor Craddock asked for a motion to approve the minutes. Councilman Thornton made the motion to approve the minutes. Councilman Farris seconded the motion. Motion carried.

Agenda:

Mayor Ricky Craddock asked if there were any adjustments to the originally submitted Agenda. With no changes, Mayor Craddock asked for a motion to approve the Agenda. Councilman Smith made the motion to approve the Agenda. Councilwoman Armstrong seconded the motion. Motion carried.

New Business:

COPS Grant:

Town Manager Gamble presented a financial projection for the General Fund in FY20-21 to determine what revenues would be needed if the COPS grant was awarded. The COPS grant is a three year federal grant that would pay 75% of the cost for a 5th officer position not to exceed a total of \$125,000. Gamble explained that the Town must commit to funding the position in year four and this commitment has to be made when the grant application is submitted on or before July 10, 2017. FY 20-21 is the first year that the Town would be responsible for the full cost of the new position (\$53,410). Gamble estimated that the Town would either have to raise taxes 4.4¢ or experience a \$3.9 million increase in the overall property valuation in Stoneville to fully cover the cost of the new position. This projection did not include the Town's Law Enforcement Officer Separation allowance obligation, which is currently estimated at \$12,240 annually. Police Chief Moore addressed the Council regarding the importance of adding a 5th officer as well as adding part-time help. After much discussion, Councilman Smith made the motion to move forward with the grant application. Mayor Pro-tem Hundley seconded. Motion carried. Councilman Farris left at 6:30 p.m., prior to the motion and vote. Copy incorporated into the minutes.

Public Comments:

Mrs. Mitzi Evans of 107 Duncan Street spoke in favor of the grant.

Mrs. Kathy Galvan of 106 Watford Drive spoke in favor of the grant.

Town Manager's Report:

Repairs to Leslie Street and the intersection of Leslie & Haywood, Haywood and N. Glenn Streets are complete.

There have been numerous complaints regarding erosion at the construction sites on White Pine Drive. The Town has approached the contractor with no corrections made, we had to involve NC DEQ Land Management. The Town has washed the intersection of White Pine Drive and Pine Cone Drive twice over the last 3 weeks and have billed the contractor.

The Booster Station roof repairs will be completed within the next 2-3 weeks, with no repairs required to the Henry Street tank shed.

Work on the final stage of the Matthews Street project should start in the next 2 weeks. Branding Project continues with the website being upgraded and planned unveiling in August. New banners, street signs, poles, wayfinding signage and trash receptacles will be ordered in July.

The Downtown Core Group has made recommendations for the Rotary Park project design and elements. Final plans, construction costs and recommended phases will be presented at the September meeting for Council approval.

The next Cruise In will be July 21st from 5 – 8 pm

No Council meeting in July.

Downtown sidewalk project is moving forward with the maintenance crew of NCDOT doing the work. Once the sidewalk is completed then the paving and crosswalks will be done.

Charlie's Soap is having a ribbon cutting on July 13th at 10 am.

Storm clean up continues with Public Works picking up debris.

ORDINANCE 0-2017-05

AN ORDINANCE TO ALLOW THE SALE OF ALCOHOLIC BEVERAGES BEFORE NOON ON SUNDAYS AT LICENSED PREMISES

WHEREAS, on June 29, 2017, the North Carolina General Assembly enacted Senate Bill 155 entitled "An Act to Make Various Changes to the Alcoholic Beverage Control Commission Laws"; and

WHEREAS, Section 4 of Ratified Senate Bill 155 authorizes city and county governments to adopt an ordinance to allow alcohol sales beginning at 10 a.m. on Sundays; and

WHEREAS, Ratified Senate Bill 155 was signed into law by Governor Rot Cooper on the 30th day of June, 2017 and became effective on that date (Session Law 2017, Chapter 87); and

WHEREAS, by enacting Senate Bill 155, North Carolina joins 47 other States in allowing alcohol service before noon on Sunday; and

WHEREAS, Sunday morning alcohol service will benefit our small business community, bring people into business districts earlier in the day, and generate increased tax revenues;

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Stoneville, North Carolina that:

Section 1. Pursuant to the authority granted by S.L. 2017-87 any establishment located in the corporate limits of the Town of Stoneville and holding an ABC permit issued pursuant to G.S. 18B-1001 is permitted to sell beverages allowed by its permit beginning at 10 a.m. on Sundays.

Section 2. All laws and clauses of law in conflict herewith are repealed to the extent of any such conflict.

Section 3. This ordinance is effective on the 1st day of September, 2017.
