Welcome: Mayor Craddock welcomed the assembly. After the Pledge of Allegiance and

Invocation, Mayor Craddock called the meeting to order.

Minutes: Mayor Craddock asked if there were any corrections to the minutes from the

last meetings. With no corrections, Mayor Craddock asked for a motion to approve the minutes. Mayor Pro-tem Hundley made the motion to approve the minutes. Councilman Thornton seconded the motion. Motion carried.

Agenda: Mayor Craddock asked if there were any adjustments to the originally

submitted Agenda. With no adjustments Mayor Craddock asked for a motion to approve the Agenda. Councilwoman Armstrong made the motion to approve the Agenda. Councilman Smith seconded the motion. Motion carried.

New Business:

Proclamation Honoring the Service of Town Clerk Marilyn Smith:

Mayor Craddock read the proclamation to everyone in attendance. He then asked for a motion to approve this proclamation. Councilman Smith made the motion. Councilman Farris seconded. Motion carried. Copy incorporated into the minutes.

Recognition of Citizen Contributions to Downtown Christmas Decorations:

Mayor Craddock recognized and thanked Cathy Brown, Jodi Lester, Betsy Shively and Linda Priddy for their contributions to the downtown Christmas decorations, each received a small token of appreciation.

Request to Close a Section of Oakdale Street:

Mrs. Jodi Lester of 200 Lee Street asked Council to consider closing the section of Oakdale Street which joins her property. Mrs. Lester stated that this road originally ended at the corner of her home on Lee Street until Mr. and Mrs. Mark Brown built their home and made this area the driveway to their home and maintain this section.

Mr. Charles Rakestraw spoke opposing the closure, stating that it would pose a hardship to reach some of the property owned by his business.

Mrs. Dixie Brown spoke stating that this area was made to be their driveway and motorist are thinking it is a throughway and turn around there.

Mr. Cliff Lester stated that he was also for the closure because of the same reasons.

After much discussion, Councilman Smith made the motion to table this discussion until the January 3, 2017 meeting to allow Council to investigate the area. Councilman Thornton seconded the motion. Motion carried. Copy incorporated into the minutes.

Resolution of Intent to Close a Portion of Oakdale Street:

Not acted upon due to tabling of item.

Replacement of Storm Drain Pipe on Oakdale Street:

Mr. Ed Brown of 109 Oakdale Street stated that the he felt the storm drain pipe was adequate and would not need to be replaced; therefore, not tearing into his well-maintained yard. After some discussion, Town Manager Gamble advised letting our Town Engineer look into the problem and go with his advice. By consensus, Council tabled this discussion until consultation with the Town Engineer.

Request for Approval of Major Subdivision Plat:

Mr. Charles Rakestraw approached Council for approval of the second phase of his subdivision. Town Manager Gamble stated that several issues needed to be addressed before approval. 1. The proposed plat will add 14 additional lots. The ordinance requires a ½ acre set aside for recreation for every 10 lots, however, the downtown trail that runs through this section could account for approximately half of this requirement. 2. The ordinance requires that hydrants be not more than 400 feet apart with the state standard being 600 feet. 3. Several items need to be added to the plat, size of the sewer line, the zoning of all property adjacent to the subdivision and an updated date of submission. After much discussion, Mayor Pro-tem Hundley made the motion that the preliminary plat would be approved on the condition that the Fire Chief would advise the number and placement of any additional hydrants to be sufficient, the current trail meets the ½ acre recreation requirement, the sewer size, zoning and date of submission must be updated. Councilman Smith seconded the motion. Motion carried with a vote of 4 to 1 with Councilwoman Armstrong voting No. Copy incorporated into the minutes.

Outdoor Fitness Project-Downtown Core Group:

Mrs. Kathy Stanley Galvan described the project and the possible locations of the equipment. Mrs. Galvan also stated that this project will not cost the Town any money, but permission was needed to place the equipment on Town property including Friendship Park, Memorial Park and the future Rotary Park. Councilman Smith made the motion to continue with this project. Mayor Protem Hundley seconded. Motion carried. Copy incorporated into the minutes.

2017 Town Council Meeting Dates:

Town Manager's Report:

Town Manager Gamble stated that the water meter pilot project is on line and the customers that are on the project can sign up on Eye on Water.

The Downtown Stroll, Christmas Parade and Tree Lighting was a great success. The addition of the Christmas Stroll was a great idea and Perry Webster did an outstanding job of putting it together. We had around the same number entries in the parade. The event cleared \$1625.00 for Parks and Recreation which was a 250% increase from last year. Distribution of Senior Treat Bags will be December 16th and a reminder of the Sustainable Utility Management Training on January 14, 2017 9AM – 3 pm.



Urban advantages. More green space within a city's boundaries can improve the urban environment. Green space advantages help regulate air quality and climate...reducing energy consumption by countering the warming effects of paved surfaces....recharging groundwater supplies and protecting lakes and streams from polluted runoff.

Water quality protection. Proper landscaping reduces nitrate leaching from the soil into the water supply and reduces surface water runoff, keeping phosphorus and other pollutants out of our waterways and preventing septic system overload.

- Oakdale Street is currently 13 feet wide. Wide enough for only one car.
- From the Brown home to the edge of the existing Oakdale Street is 22 feet.
- From the Lester home to the edge of the existing Oakdale Street is 40 feet.
- Current Stoneville road ordinances require a width of 50 feet for town roads. That is 25 feet from center line to the town's right of way. If the road is to improved for traffic that will only leave 3.5 feet from the edge of the right of way to the Brown home.
- How can this be improved for both vehicular and pedestrian traffic?
- Cars fly down around that corner thinking that it is an open street only to skid to a stop before hitting the woods and the creek. There is a very deep drop off just beyond Lee Street. IT IS A HUGE SAFETY ISSUE!!!!
- Walking trail easement is in place and will have to be crossed by vehicles for Oakdale Street to be extended to Price Street.
- The development of Stoneville should be carefully and educationally considered to protect green space and the lovely, historic characteristics that make up this beautiful town. Natural resources should be protected above all else.
- Price Street is less than ½ mile long. There is not any reason why there
 needs to be more than 2 ways to access it.
- The Browns have maintained that section of Oakdale St. paving it and with snow removal. The town has never maintained that section of street.

Under G.S. 160A-299, a municipality may permanently close a street or public alley within the municipal limits or extraterritorial jurisdiction. This applies to streets and alleys that have been opened and maintained as public, as well as property that was offered for dedication to the public by plat but never accepted or maintained by the municipality.

Council may adopt an order closing the street or alley if council is satisfied "that closing the street or alley is not contrary to the public interest, and that no individual owning property in the vicinity of the street or alley or in the subdivision in which it is located would thereby be deprived of reasonable means of ingress and egress to his property." For NCDOT-controlled streets or alleys, NCDOT must consent to the closing.

Private Withdrawal

Under certain circumstances a dedication that has not been opened and used may be withdrawn by private parties.

If property dedicated for a street is not actually opened and used by the public within 15 years of dedication, the dedication is presumed abandoned and certain property owners may withdraw the dedication. G.S. 136-96. The dedicator or an individual claiming rights under the dedicator must record with the register of deeds a declaration withdrawing the dedicated property. There are limitations, however. Where dedicated property is necessary "to afford convenient ingress or egress to any lot or parcel of land sold and convey by the dedicator," the dedication may not be abandoned and withdrawn. Additionally, property dedicated to be part of a future street shown on an adopted street plan pursuant to G.S. 136-66.2 may not be abandoned and withdrawn.

The right to withdraw is not enjoyed generally by lot purchasers. The statute authorizes withdrawal by "the dedicator or some one or more of those claiming under him." Those claiming rights under the dedicator will depend upon the rights conveyed to lot purchasers and the organizational structure of the developer and/or homeowners association. In one case, the court of appeals found that because the dedicator was an individual and retained fee interest in the streets, the individual lot owners only had an easement and could not withdraw the dedication of the underlying fee interest. Town of Atl. Beach v. Tradewinds Campground, Inc., 97 N.C. App. 655, 389 S.E.2d 276 (1990). By contrast, if the dedicator had been a corporation that became defunct, then the lot owners may have had more rights under G.S. 136.96.

Private Rights

It is worth noting that even if a public right-of-way is closed or withdrawn, private rights for the use of that property may still apply. In Stephens v. Dortch, for example, a property owner sought to withdraw dedication of a certain segment of street from an old subdivision. Neighbors objected. The court upheld the withdrawal of dedication, as the area was never accepted by a government entity for maintenance nor used by the general public, but the court also found that neighbors had an easement appurtenant (and more rights than the general public). 148 N.C. App. 509, 510, 558 S.E.2d 889, 890 (2002).

Conclusion

Closing the un-opened street? The property owner possibly may seek withdrawal, but it will depend on the rights of that owner under the original dedicator. Alternatively, the town could initiate a closure under G.S. 160A-299. Again, if the town followed the proper procedure and made the requisite findings, it could formally close the unopened street.
