# Stoneville Town Council Meeting Minutes December 5, 2017 7:00 PM

Present:Present were Mayor Ricky Craddock, Councilwoman Lori Armstrong,<br/>Councilmen Henry Thornton, and Jerry Smith. MayorPro-Tem Chuck Hundley<br/>and Councilman Bill Farris were absent. Newly elected Councilman Johnny<br/>Farmer was present and seated after being sworn in.

Also, present were Town Manager Ken Gamble, Human Resource/Finance Officer Joanna Dalton, Town Clerk Sherri Darnell, Police Chief Frank Moore, Police Captain Brandon Rivera, Police Officer Matt Michaels, Police Administrative Assistant Perry Webster, Public Works Director Mark Malloy, Fire Chief Tim Brown and Town Attorney Lisa Arthur.

- Welcome:Mayor Ricky Craddock welcomed the assembly. After the Pledge of<br/>Allegiance and Invocation, Mayor Craddock called the meeting to order.
- Minutes: Mayor Ricky Craddock asked if there were any corrections to the minutes from the last meeting. With no corrections, Mayor Craddock asked for a motion to approve the minutes. ## **New Business:**

# **Council Organizational Meeting:**

### **Grant Applications for Fire Chief Vehicle:**

Fire Chief Brown asked Council for approval to apply for grants to obtain a Fire Chief's take home vehicle. One grant application will be through the NC Office of the Fire Marshall and the other through USDA. Chief Brown stated that he anticipates 100% of the costs to be covered if both grants are approved. Councilman Smith made the motion to proceed with application for both grants. Councilwoman Armstrong seconded. Motion carried.

## **Town Council Meeting Schedule for 2018:**

Town Clerk Darnell presented the schedule stating that the only deviation from the first Tuesday, would be in November due to elections the meeting would be held on the second Tuesday. Councilwoman Armstrong made the motion to accept the meeting schedule. Councilman Thornton seconded. Motion carried. Copy incorporated into the minutes.

### FY 2018-2019 Budget Calendar:

Town Manager Gamble stated that incorporating budget meetings into the regular meeting dates worked well last year and proposed continuing the process; therefore, allowing the budget ordinance to be passed at the June meeting. No vote was required on this item. Copy incorporated into the minutes.

### Get Fit Rockingham Partner Grant:

Town Manager Gamble explained the municipalities had a meeting with the Kate B. Reynolds Foundation staff to expand the Get Fit Eden program model throughout Rockingham County. Mr. Gamble would like for Stoneville to be included in the grant and would like to be able to expend \$1,000.00 if the grant is either late or not approved. Councilman Farmer made the motion to approve. Councilman Smith seconded. Motion carried.

Chief Moore stated that Mr. Barry Stuart had made a comment to him that he would like to Sponsor next year's parade.

#### Town Manager's Report:

Town Manager Gamble stated that the Christmas stroll, parade and tree lighting were all well attended and after costs, profited \$700.00 for Parks and Recreation.

The NC Realtors Revitalized Communities will be shooting stories across the state about communities making their downtowns successful. The Stoneville Downtown Core Group will be a part of this story with interviews and stories being shot on December 14<sup>th</sup>.

Senior Christmas Treat bags will be delivered on December 14<sup>th</sup>.

### **Executive Session:**

# STATE OF NORTH CAROLINA

AN ORDINANCE CREATING SECTION 091 IN CHAPTER 151 OF THE ZONING ORDINANCE OF THE TOWN OF STONEVILLE, NORTH CAROLINA

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Stoneville, North Carolina that the following Section of the Zoning Ordinance of the Town of Stoneville is hereby created and added to District Regulations:

# **District Regulations**

§ Section 151.091. DEVELOPMENT REGULATIONS

(A) Allocation of 10/70 Impervious Surface Area by the Town Council – In addition to the development allowed according to 151.085, 151.086, 151.087, 151.088, 151.089 and 151.090 of this section, new development and expansions to existing development may occupy up to ten percent (10%) of the protected watershed area with up to seventy percent (70%) built-upon area on a project by project basis.

- For the purpose of this section, Allocation of 10/70 Impervious Surface Area shall mean that up to 10% (ten percent) of the acreage designated as Protected Watershed may be developed with up to 70% (seventy percent) impervious surface (built upon area).
- 2) Such allocation may be approved by the Town Council as a Special Intensity Allocation (SIA) of up to 70% (seventy percent) of the built upon area of a project.
- 3) Applications for SIA shall be submitted to the Zoning Administrator and shall include a site plan in conformance with the development requirements of the Town of Stoneville Zoning Ordinance. All applications and site plans must include the following information:
  - (i) Project Timetable
  - (ii) Anticipated addition to the property tax base
  - (iii)Anticipated number of jobs to be created or retained
  - (iv)Additional information as requested by the Zoning Administrator, Planning Board, Town Council in order to determine if the application meets the criteria for approval
- 4) All Sites shall be designed in accordance with the State of North Carolina Water Supply Protection Rules. All projects must to the maximum extent practicable minimize built-upon surface area, direct storm water runoff away from surface waters, provide a minimum one hundred (100) foot vegetative

buffer along all perennial waters and incorporate best management practices to minimize water quality impacts. For the purposes of calculating built-upon area, total project area shall include total acreage in the tract on which the project is to be developed. The Town of Stoneville may impose site plan conditions in order to meet these requirements

- 5) The Town of Stoneville's approval of a SIA shall be on a project-by-project basis and shall be based on the following specifications:
  - i. Economic benefit to the Community by creating and/ retaining jobs
  - ii. Increase on the property tax base
  - iii. Compatibility with the Town of Stoneville Land Use Plan and character of the area and surrounding land uses
  - iv. Project does not pose a threat to the environment, especially water quality and that appropriate measures will be taken to minimize any potential negative environmental impacts
  - v. Any other factors the Town Council deem necessary in making a decision
- 6) The Planning Board of the Town of Stoneville shall review all applications for SIA, and shall submit a written recommendation to the Town Council before a final decision is rendered.

# STATE OF NORTH CAROLINA

AN ORDINANCE AMENDING SECTION 013 OF CHAPTER 151 OF THE ZONING ORDINANCE OF THE TOWN OF STONEVILLE, NORTH CAROLINA

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Stoneville, North Carolina that the following Section of the Zoning Ordinance of the Town of Stoneville is hereby amended:

§ Section 151.013. HEIGHT OF BUILDINGS.

In order to preserve for all land users an adequate amount or light and air, and to lessen the possibilities of a conflagration beyond the capacities of local firefighting units, no structures in the RA (RESIDENTIAL AGRICULTURE), RS (RESIDENTIAL SUBURBAN), B1 (BUSINESS, OFFICE AND INSTITUTIONAL) and HB (HIGHWAY BUSINESS) districts shall be built to exceed 35 feet in height. No structures in the I-1 (PLANNED INDUSTRIAL) district shall be built to exceed 60 feet in height. Church spires, flagpoles, antennas, chimneys and similar accessories to buildings are exempt from this height limitation.
